

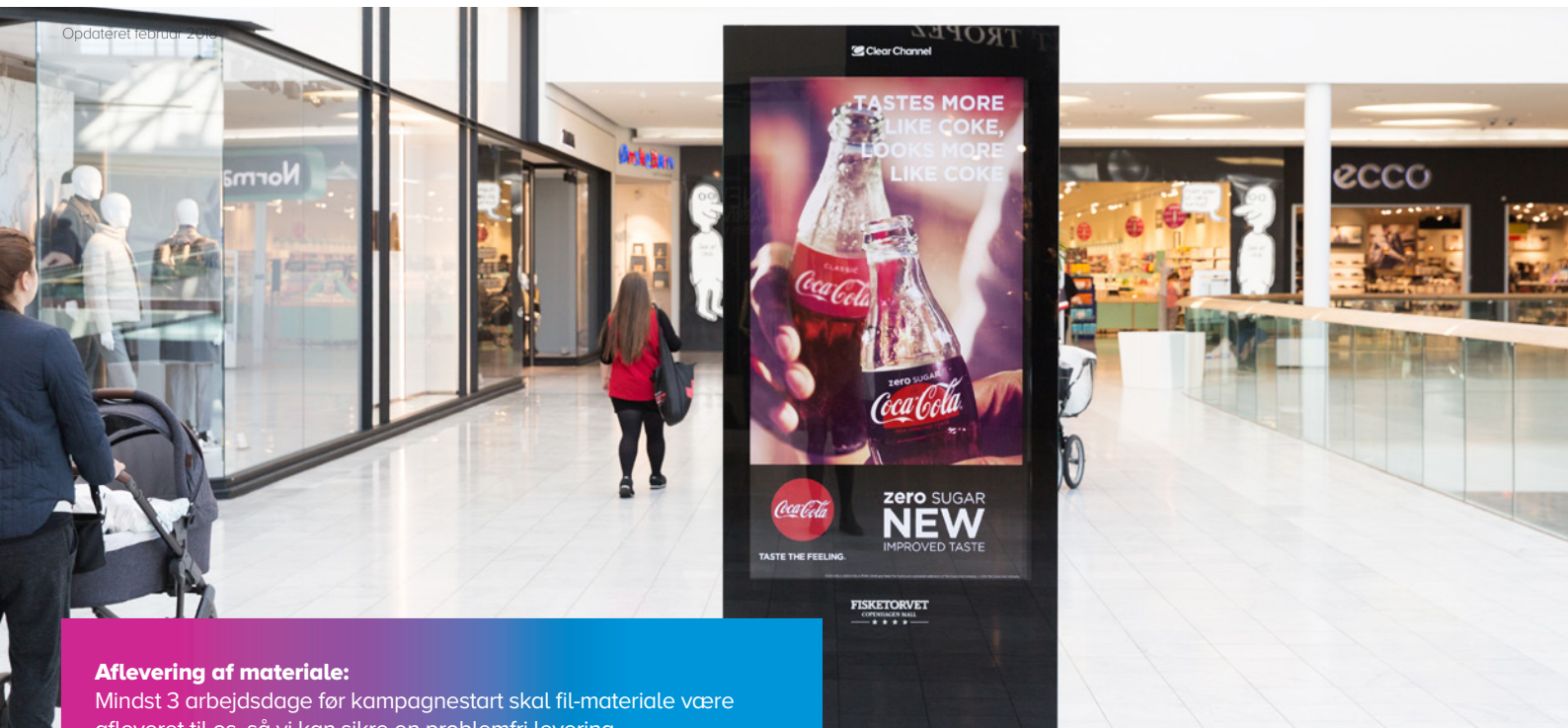

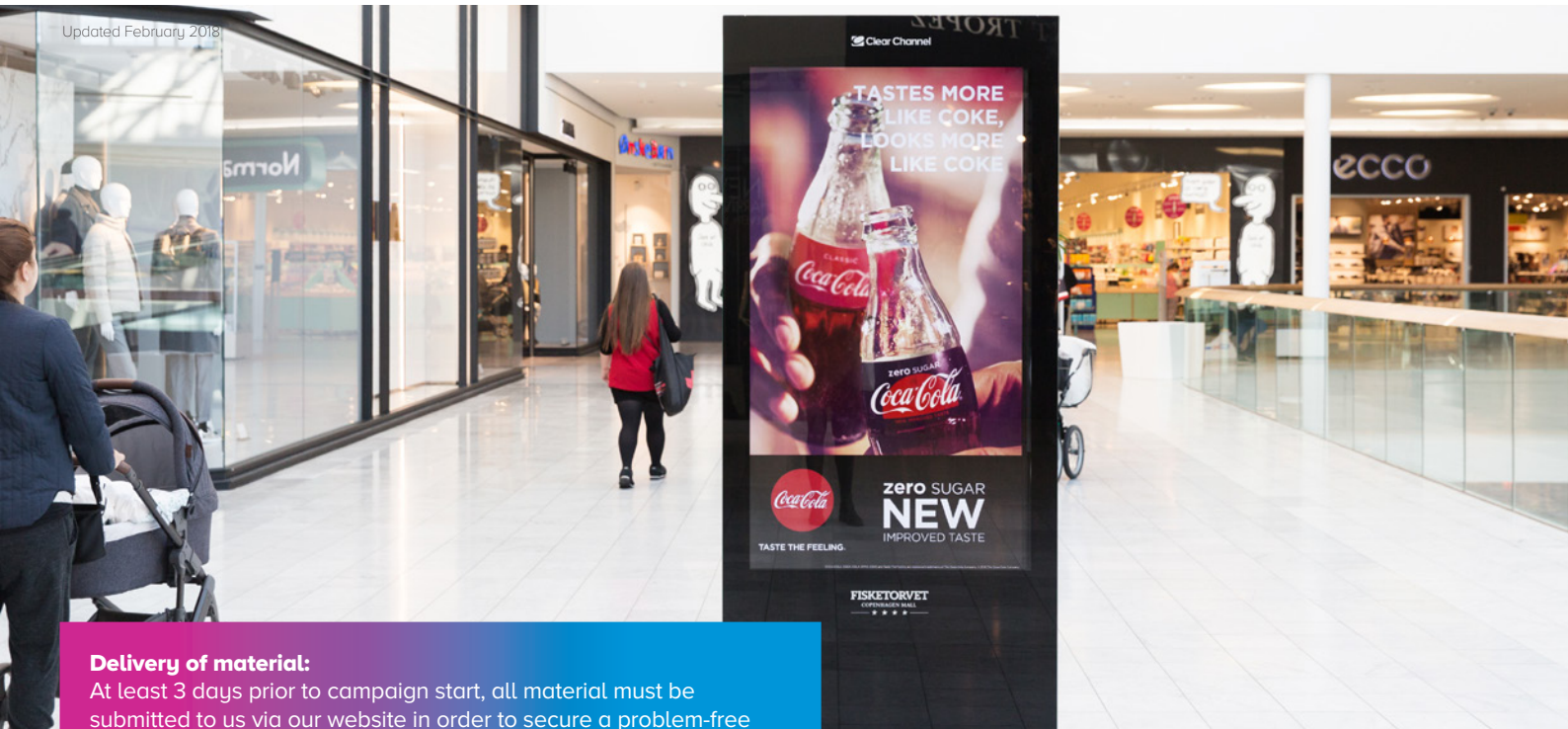

Dynamic content:

- HTML5
- Browser: Chromium 52 Embedded Framework with integrated cache functionality.
